RESEARCH IN PROGRESS

Jeffrey Feldman (New York University) is carrying on research on Italian physical anthropology from the emergence of Darwinism to the solidification of a fascist racist program, with the working title "Dante's Bones," and a focus on Giuseppe Sergi and his student Fabbio Frassetto, chair of the University of Bologna department of anthropology in the first third of the twentieth century.

Louis Heib (University of Washington), having just submitted for publication an edition of H.F.C. ten Kate's <u>Travels and Inquiries in North America</u> (1885), is beginning research on ethnologists who worked at Hopi from 1879 to 1894.
